## Photographs & Filming (Students: Year 9 onwards)

To comply with the General Data Protection Act 2018, we need your permission for each medium before we can photograph or make any recordings of you for promotional purposes.

## **Conditions of use**

- 1. This consent is valid for the period of time you are part of the Townley Grammar School Community (including the Alumni).
- 2. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video, on our website/social media, in our school prospectus or in other printed publications.
- 3. If we use photographs of you, we will not normally use your name in the accompanying text or photo caption without your permission. However, on occasion we may use forenames to accompany photographs and news items and in some instances the surname may be included. We will request the press does likewise but we cannot guarantee they will comply.
- 4. We do celebrate your achievements and events; therefore, photographs can be displayed in classrooms and noticeboards around the school.
- 5. We may include pictures of you and teachers that have been drawn by you.
- 6. We may use group or class photographs or footage with very general labels, such as "a science lesson" or "the intermediate choir".
- 7. We will only use images of students who are suitably dressed, to reduce the risk of such images being used inappropriately.
- 8. We also maintain a secure archive of our whole school photographs, event images and programmes to maintain the history of Townley Grammar School.

Where it is necessary to film or take images for examination purposes, these are also protected by the rules and regulations of Joint Council for Qualifications and the awarding bodies and are not included in this consent form as they are a legal requirement to complete the examination process.

All students and staff are required to have an image on our Management Information System as part of our security and safeguarding procedures.
